#### NOTABLE:

Brian Virgili v. Newport Crest HOA and Optimum Property Management – Ms. Van Wagner assisted in achieving a defense verdict on all causes of action in a 12-day homeowner versus HOA/property management trial in Orange County, California. The plaintiff alleged that water intrusion from the exterior of the building was the cause for mold growth and mycotoxins within his unit. The defense was able to show causation stemmed from homeowner responsible areas and that the homeowner's claims for damages were unfounded. The defense pre-trial motions in limine and motions for non-suit resulted in large portions of the plaintiff's case being thrown out, including the exclusion of some or all of the anticipated testimony of plaintiff's retained experts.
